
Harold E. (Spike) Smith, NCE

dio and Telecommunication Engineers. Master endorsements in rf and non-radiating telecommunications systems engineering.



Microsoft Answers

Statistics by Microsoft Excel

One of my favorite books is *How To Lie With Statistics* by Darrel Huff. It was written (tongue in cheek) forty years ago, and the numbers in the examples are out of date, but the horrible methods it exposes are still being used by those who would try to mislead.

Statistics are neutral. They are tools which can be used to clarify or to muddle. Used properly, statistics can illuminate truth in a very succinct manner. Excel's(R) statistical capabilities are ideal for doing this in a spreadsheet presentation.

Excel(R) has a set of statistical functions to use in spreadsheet calculations, plus a set of statistical procedures for more comprehensive work, contained in the "Analysis Tool Pack (ATP)." These functions and procedures are somewhat more extensive than those taught in "Statistics 101," but are not comprehensive in the field. For standard, run-of-the-mill statistical calculations, they are hard to beat. For highly specialized work, unless you are into "coding your own" in a Visual Basic for Applications (VBA) macro, I recommend going to one of the many fine standalone statistics packages on the market. Excel is capable of doing all these specialized calculations, but the specific spe-

cialized procedures are not written into the program.

Categories of statistical functions: Excel's functions can be categorized into these groups:

- Counting and Order
- Average, Mean, Variance, Standard Deviation
- Significance Tests
- Probability and Frequency Distributions
- Analysis of Variance (ANOVA), Linear Regression

Collection Looks Overwhelming...

This collection looks overwhelming if you are a statistical novice, but we still get lots of calls from customers who want more. When we get enough requests, we may write macros or worksheet procedures for our Knowledge Base (KB), or we may post articles at our Internet Web site (Home page is WWW.Microsoft.com). These articles, from both sources, are available to everyone. Occasionally, these procedures may be picked up and coded into the next version of Excel.

We can't help everyone who calls asking for help with statistics. Once we got a call from a lady

who had done a regression analysis, and wanted help with the significance figures. She wanted us to tell her whether her results were significant or not.

'Significance' Often Misunderstood

When I talked with her, she had already been through three Support Engineers (SE's) and one other Escalation Team member.

I had to reiterate that we couldn't do that - that was her responsibility, and there was no way we could know enough about what she was doing to interpret the significance results.

On the other hand, there are some fun calls. One call we get a lot, concerns ranking. The teachers love ranking their students ("10 are in the upper quartile, 20 are in the second quartile, etc."). Any ranking calculation can be destroyed by perverse data. For instance, how do you do a ranking if all the scores are the same?

It doesn't make any sense. Because of this, every author in statistics has his/her own way of compensating for pathological data. Every statistics book has its own algorithm for calculating ranking, and none of them are even equivalent.

Excel(R) has a good one, but it's just one of many. I tell the customers, "Tell me how you want to do the ranking, and I'll write you a solution for doing it your way!"

Lastly, many customers call in, saying that our hatever function is different in the sixth significant figure from somebody's calculator program, and what are we going to do about it? Statistics is a science of computing probabilities and making approximations, and the sixth significant figure is of little use to almost everyone (there are occasional uses for such accuracy). I have a lot of experience doing statistics in the real world of process experimentation, and I have never seen any need of calculating statistics beyond three significant figures. The real world just isn't that precise. Excel has more than all the precision you will ever need for doing basic statistical work on real problems.
