



Web Survey Results of Web Viewers

This month we added a Web survey to our Web site to get some feedback from our users about their Web viewing preferences. Of the 141 responses, 140 were from members.

Why did we do this? We wanted to set our Web site up for the most used screen parameters, i.e., to make sure that our "average" visitor to the NTPCUG Web site wouldn't be unduly inconvenienced by our format/layout.

Results of the survey are tabulated below and tend to confirm that industry standards are inline with published user predictions. Obviously, one conclusion from this brief survey is that monitor "size creep" is alive and healthy, since the average user views our Web site for a 17" monitor set for 800X600 dpi screen resolution.

About 94% were PC users, 3% were Macintosh users, and 3% were Linux users. Almost 25% were laptop users, and the rest were desktop users. About 94% used Internet Explorer 5.x, about 3% used Netscape 4.x, and about 3% used other Web browsers (including AOL) as their primary browsers, and about 18% used additional browsers.

The average user's monitor size was 17", as seen in the following table. This does not take into account users who may be using one of the new flat-panel displays.

Pile them high and wide. If you know somebody is coming to your cubicle, bury the document you'll need halfway down in an existing stack and rummage for it when he/she arrives. 4... **Voice Mail**. Never answer your phone if you have voice mail. People don't call you just because they want to give you something for nothing - they call because they want YOU to do work for THEM. That's no way to live.

Screen all your calls through voice mail. If somebody leaves a voice mail message for you and it sounds like impending work, respond during lunch hour when you know they're not there - it looks like you're hardworking and conscientious even though you're being a devious weasel.

Paranoia just may be a Healthy Habit On the Web in Light of Carnivore, Adbots, and Non-innocent Cookies

Looks Like Andy Grove was right

Such a month! I've enjoyed the non-Microsoft news more than I would have imagined possible after last month's revelations of "Dumpster Diving" by shady private investigators in the employ of Oracle. This month is even better with *Carnivore* uncloaked and the e-mail security issues it raises, followed by some very interesting revelations about Netscape's escapades concerning users' privacy. Makes me feel right at home.

Big news was interesting tidbits about the FBI's super E-mail snooping program, Carnivore, and reluctance of ISP's to allow attachment to their systems even with subpoenas. Lots of right-to-privacy questions raised by the issue, which are intensified by the initial (Janet Reno) refusal to reveal the source code involved. Fact that Carnivore apparently "crashed" one major ISP's servers makes it even more fun.

CARNIVORE? WHAT'S 'MEAT EATER' HAVE TO dO WITH COMPUTERS & E-MAIL?

What's Carnivore, and what's all the "right to privacy" controversy over the FBI-sponsored program(s). Actually, Carnivore is a "black box" that the FBI wishes all ISP's would attach to their servers. Nobody (so far) knows what is inside the box, but sev-

eral ISP's have discovered, much to their chagrin, that Carnivore can bring their servers "down to their knees" as a result of software incompatibilities.

Carnivore is actually a method of tapping into ISP users' E-mail transmissions. It is supposed to be selective, but ISP's aren't sure about that aspect of the subpoena-forced system on their backbones. Civil rights groups are upset because of this aspect of Carnivore's operations, or because they plain don't trust (with excellent history of the bureau's past misdeeds along these lines) the FBI to restrict their searches to the targets of the

(Federal Court) subpoenas forcing them to comply with the FBI's demands. A lot of this mistrust goes back to the days of J. Edgar Hoover (hopefully, when he wasn't cross-dressing) and the FBI war against Vietnam War protesters when FBI agents provocateur were in flower among the various antiwar organizations.

ISP's Worried About FBI And 'Right to Privacy'

ISP's involved are worried that the FBI E-mail sweeps may be much broader than the FBI admits since none of the innards of Carnivore are known and understood by the ISP community. This concern has been mirrored in several "right to privacy" advocates who tend to view this as just another Federal incursion by "Big Brother" into and curtailing the rights of private citizens to privacy of communication with others.

These groups, including the Americans for Civil Liberties, have pressed the FBI and Janet

Reno to make public the innards of Carnivore. Ms. Reno originally demurred, stating that making the source code public would make it possible for the "bad guys" to contravene the usefulness of Carnivore by erecting defenses against the program(s).

Can't Remember if 'Child Pornography' Card Played in Denial

(I don't remember if Ms. Reno played the usual "child-pornography & drug dealers" card in her defense of Carnivore, but that's the typical Federal excuse for abridging the rights of the public by one of her agencies. (You may have gathered that I'm not an advocate of either Carnivore or Reno in this matter.)

Turnabout Fair Play?

This all seems a little strange in light of Janet Reno's minions (DOJ) demanding that Microsoft, a private concern, make the source code of *Windows* available to all and sundry in the *Microsoft v. Entire Known Universe* antitrust suit in Judge Jackson's court.

Here's the rub: Federal agencies who develop computer programs/systems are supposed to make them available to the general public. I do know the VA had to make their version of MUMPS and the database systems developed for running the VA hospital systems available, and were bound by this rule. I can't imagine why the FBI is any different.

RENO RELENTS But, Who will Judge?

Reno has relented to some degree and allowed the FBI to set up an "outside review" of the Carnivore E-mail tapping system, and (WSJ) pledged to personally approve the selection of the organization that will investigate how the Carnivore software works. Now, this is a problem for me. At first, Ms. Reno definitely doesn't want to reveal the workings of Carnivore, then relents and agrees she'll select a "suitable organization" to look into the E-mail snoop's innards. Am I the only reader who sees this as just one more instance of the "fox guarding the chicken coop?"



(Ooopppsss "fox" was most definitely the wrong noun in this case.)

If I let my somewhat paranoid imagination run free, I could develop a fantasy that Janet will call in the NSA (National Security Agency—the nation's premier communications snoops) to do the audit. My problem is that the NSA certainly has the in-house expertise to create a system such as Carnivore, but is strictly prohibited from utilizing such tools (as is the CIA) against American citizens within the continental US. However, is it equally prohibited for the NSA to "sell" such a program to the FBI? I don't know. Nor do I know if the FBI agreed to "do a little 'extra' snooping" on the NSA's behalf while employing Carnivore against the "bad guys."

Talking About Atrocious PR, 'Carnivore' Name Has to be Massive Blunder

I've followed Federal burocratic stupidity for most of my time as a "Career Federal Employee" and this has to be right at the top of the heap. How could anyone with any sense of public sensitivity deign to name a program/device aimed at destroying one of the most basic tenets of the Constitution 'Carnivore'?

Sorry, Janet, but this almost parallels your handling of the Branch Davidian, failed ATF fiasco in search of "good" PR via TV coverage of their abortive raid on the Waco, TX, compound. Surely you could have found a better name that wouldn't have raised public hackles and paranoia. How about 'Sentinel,' or even 'Pansy' as better alternatives to a name associated to rapaciousness?

Even 'Dinosaur' would have been better. And, less likely to rekindle the public distrust of an already questionable department of the Federal establishment.



TEMPEST IN A TEAPOT? NOT LIKELY SINCE AN 'OLD' TECHNOLOGY STILL THREATENS CURRENT USERS

That's *Half* the story. The other half is "Tempest." Tempest (and, I've written about it before, in the mid 1980's) is a program to eliminate the possibility of "reading" the user's screen displays as the user employs their PC in "interesting" tasks. Point: all PC monitors (unless shielded) emit RF signals in use. A good, highly-directional antennae and amplifier can pick up these signals and make the user's display available to others (with the appropriate gear) quite easily and from a distance of several 100's of yards. The security-conscious agencies in the federal domain know this, and have been soliciting methods of stopping/shielding PC's from such monitoring.

Problem is that anyone with the will and appropriate equipment can conduct such snooping. Compounding the issue is that the gear involved really isn't that difficult to acquire since it isn't all that "high tech" at this stage of the game. WSJ reported shielding systems for PC's



costing in the \$30,000 range. Doubt that many businesses will spring for this kind of cash to protect all the PC's in their purview. Result is vulnerability whether from industrial espionage or Federal snooping.

Caveat emptor.

Sinister is as Sinister does AOL/Netscape's Turn in Security Breach Barrell

After months of hearing about IE and security breaches in *Outlook* and *Outlook Express*, it's AOL's turn to blush. Turns out there's a "massive" security hole in *Netscape Navigator* and we can blame it on *Java*. According to a *Wall Street Journal* article by Ted Bridis, Navigator is very vulnerable to penetration by hackers (gosh, I remember when 'hacker' was a term of admiration for someone unusually gifted in making disk operating systems perform well) and allows intruders to "View and retrieve files from a victim's computer or office network after the victim merely opens an E-mail or visits a Web site."

Turns out that companies are more likely to be hit than individual users (unless they are among the 15% who hate Microsoft and use Navigator instead of Outlook or Outlook Express.) Reason is that companies rely on the

AOL/Netscape product in numbers far exceeding the home user base. According to the WSJ article, companies "tend to choose Navigator more than the MS product—likely as a result of the "bad" press on the MS family of mail readers of late.

One interesting aspect of this is that *All* platforms using the Netscape product, and that includes Windows and UNIX (Solaris) are vulnerable to the Javabased intrusions. The *WSI* article continues

that "the flaw allows a malicious program to exploit the way Netscape handles particular Java commands" which can allow Netscape's browser to function as a miniserver that allows others to view or retrieve a user's files without any warning.

Netscape said they are tasking engineers to "look into the problem, if any."

SpyWare Comes to the Fore As Steve Gibson Unravels Treacherous Cookies From Netscape, Other Vendors Installed on Systems

Wow! I didn't know this although I've suspected it wouldn't be too long until it happened. Stumbled across this while looking for an "Adbot" defense. Used Google.com in a search for data and came across the following from the Web site owned by Steve Gibson of SpinRite fame. (www.grc.com)

First, "Adbots" are little programs that often ride piggyback on shareware programs and report back to vendors about users Web surfing habits. One reason Steve Gibson's name came up was *OptOut*, a beta program available for free (now) to search for some of the more notorious Adbot dispensers, such as Aureal (*aureal.dll*).

What I found on *grc.com* (Gibson Research Corporation) was a lot more interesting and a lot more important to PC users (and Apple users). Seems that users of NETzip-descended file downloaders are giving away a lot more information about themselves than they realize. Netscape gets caught up in this again. Reason is Internet file downloaders place "cookies" on the users' PC's that report back a lot of information about the users that they may not wish others to have.

Gibson has been having a rather dynamic interchange with officials of Netscape, RealNetworks and NetZip over the behavior of their respective file downloading programs. In the case of RealNetworks (and others) the "cookies" installed on the users' systems report back with details about the files downloaded, the URL of the location where the files were obtained, the user's personal name and aliases, Email address and the user's unique ID tag assigned to the user's PC as well as the PC's individual IP address. Scary, huh?

I'd suggest users pay a visit to Steve Gibson's Web site and peruse the ongoing interchange between Steve and the various vendors of these programs. URL is http://grc.com/downloaders.htm. I can gurantee it will inform—and curl your hair in the process.

I did take opportunity to download Steve's latest product, OptOut.EXE, from the site which is designed to snoop the user's system for various Adbot DLL's and discovered that my primary PC was "clean." Think it's worth anyone's time to visit, read and download OptOut.EXE. Since I don't use Netscape or their utilities, didn't feel personally involved in the rest of the tale, but would suggest that any user who does use the AOL browser read the .HTM file.

ous server databases. Larry will draw on his experience using Access as a client to Microsoft SQL Server, Informix, Sybase SQL Server, and Sybase SQL Anywhere. Because it is a database development tool, and has unique data-related events and properties, Access is an excellent tool for developing client applications.

At the July meeting: Access SIG Leader Larry Linson led a discussion on "Access in a Multiuser Environment." We talked about tips, hints, considerations, and caveats for using Access with multiple users. Larry quoted reliable reports of as many as 150 concurrent users, though he certainly doesn't advise that you *plan* an Access application for that many. One topic of particular interest was "Corruption and How to Avoid It" — the identified cause is most often a case of "ungraceful termination."

Expect another nice assortment of goodies in our giveaway, courtesy of Microsoft User Group Support, the Microsoft Developer Network, donations from members, and even a few freebies that Larry has gathered or created.

Coming soon to the Access SIG:

Freeware Tools: Boost your productivity for free. Reviews of and references to tools generous developers have made available for download from the Web. For our August meeting, Co-SIG Leader **Larry Linson** will lead a discussion of "VBA Add-Ins for Office 2000 Developers," including the Code Librarian, Code Commenter, Error Handler, Multi-Code Import/Export, and String Editor. These handy add-ins are provided in the Office 2000 Developer Edition, so the 'price is right'. July Meeting

Co-SIG Leader Larry Linson gave a presentation on "The Use of Microsoft Access in a Multi-User Environment." Do you know who your computer is talking to when you're sleep? We will be discussing Spyware in our August meeting. Find out who is spying on you and your computer. Cable modem and DSL users are at risk because large files can be transferred quickly. If your files are interesting they have your address for a return visit. Dial-up users have some risk because slow connections would allow an outsider to download your cookies, user profile or history file. Cookies contain names, addresses, phone numbers, credit card numbers, e-mail addresses and passwords.

Spyware is obtrusive, destructive and maybe adding 10MB to your hard disk just for the purpose of reporting and attempting to sell something to the Internet user. Freeware may be available at no cost but how many strings are attached. Have you ever installed a program and a companion program was included and available for installation. We will discuss the large marketing companies and their attempts to control your browser and influence your choices. Companies that spy on consumers have used cookies. The new I.E. 5.5 has given the Internet user a choice of the cookies they will accept. The newest technique of commercial sites is attempting to log on to a surfer's computer using Netbios.

Trojans and keyboard recorders pose additional risk for all Internet users. The August discussion will include firewalls, packet analyzers, Netbios and how to purge these invisible snitches and annoyances from your computer. We will discuss techniques and defensive measures you can take to control your privacy.

Tips and Utilities for CorelDRAW 9


For our August meeting, SIG member Bob Wright will discuss and demonstrate tips and utilities for successful output from DRAW and PHOTO-PAINT. As a print shop owner and early-day computer user, Bob's expertise since 1984 includes graphic design using various graphics and publishing software, which is then output to film for commercial printing. Whether using spot color or 4-color process, he has been a fan of CorelDRAW since version 4. Bob will show us how to make custom color palettes and templates; discover the power of Dockers and Object Manager; understand pre-press features, including crop marks and registration marks. Don't miss this valuable learning session.

July in Review

Marsha Drebelbis was inspired by author Rick Altman's conference examples of customizing CorelDRAW's interface. So July 15 her topic addressed the efficiency and productivity gains of "Customizing the Interface" of our own DRAW and PHOTO-PAINT

to suit the way each of us works. Until now, most of us just contaminated Corel's 'default' interface when we saved our own preferences. However, we learned how much better and how easy it is to save our own customized interface. Save it under a new name. This will enable you to promptly bring your own CorelDRAW look and preferences to whichever computer you are using. Do you want a Nudge button on the menu bar at all times? Just hold down ALT and drag it up there. We lost (accidentally deleted) the B button for bold fonts for awhile, but never fear. We just restored it by going to Tools, Options, Customize, Toolbars, Text, Font, Bold. Then we selected 'text' for the Property Bar and Saved it. The B button was restored. Whew! After naming and saving your own interface option, restore Corel's default interface by holding down F8 while restarting the program. Create as many interfaces as you need. The handout sheets provided full details.

Lose the book to your Corel clip art CD's. Use instead the graphics file viewer called **RomCat** v4.0. Marsha demonstrated it in July's meeting. RomCat was designed, many Corel versions ago, to catalog the directories and collect keyword information for CorelDRAW's Clipart CD's and display thumbnails from CorelDRAW files. In RomCat, just type in your keyword and let RomCat find the match-

ing art files on the CD. It works for all versions of DRAW. You can catalog and keyword your own .cdr, cmx., .cdt, and .pat files too. Foster D. Coburn III prebuilt catalogs for DRAW CD versions 6, 7, 8, 9, and cgm (Corel Gallery Magic) and they are available for you to download FREE via links on our own Dallas Corel Web page. There is simply no better way to find Corel clipart than to use RomCat. And the best part is the cost: it's FREE! ACD **See** v3.0 is the best graphics viewer/browser for graphic files other than DRAW's. The new version supports digital cameras too. You can download this shareware at http://www.tucows.com.

We are continually surprised that so many Corel users still don't know the best font management utility is right on their Corel installation CD. It's been included for the past several versions.

Font Navigator is the best and we took a peek at it during our meeting. Don't throw away ATM, but definitely install Font Navigator and start enjoying its unique features and ease-of-use immediately. You can install this at any time. When starting a fresh Corel installation, remember to check Font Navigator during a custom installation and it

In CorelDRAW 9, you can apply Artistic Media strokes to curves. This feature allows you to apply interesting lines to the outline of your curved objects.

To apply Artistic Media strokes to curves:

- 1. Click Effects, Artistic Media.
- 2. In the Artistic Media Docker window group list box, choose a folder that contains strokes.
- 3. Select a curved object with the Pick tool.

4. In the Artistic Media Docker window, click a stroke, and click the Apply button.

Using the Loupe Zoom feature in Corel KnockOut masking software

In Corel KnockOut masking software, you can use the Loupe Zoom feature to magnify a circular area that can be moved around the object. This allows you to work with the selection tools more easily because you can zoom in on the edges of the object you want to mask.

Broadband" by Linden deCarmo which appeared in the September 1, 2000, issue. This follows a somewhat hectic series I've been looking into with interest on the issue of "privacy" both in *PC Magazine*, and in the *Wall Street Journal* of late. (See *Variety Store* this issue.)

In addition to the "always on" danger inherent to broadband Net connections by either cable or DSL, I'm concerned with "adbots" and unintended "visitors" to my PC while on the Net. I've responded to both threats via a couple (actually three) of shareware programs



designed to enhance the concept of privacy when surfing the Net.

The three are Steve Gibson's *OptOut*, Zone System's *ZoneAlarm* and *Cookie-Crusher*, all downloaded from various Net sites. *OptOut* is a beta (i.e., preproduction version) program designed to rid the system of pesky "adbots," while *ZoneAlarm* is a firewall designed to stop "intruders" from hacking into my systems. *CookieCrusher* is a program aimed at eliminating the personal privacy problems posed by Web sites placing cookies on my system to track where I go on the Net and what my preferences may be.

While I like all the programs above, I do feel that I really don't have the "real" knowledge to appropriately configure ZoneAlarm and plan to grab some more facile and knowledgeable NTPCUG expert to come to the DOS/Operating Systems SIG in the near future and give a tutorial on the program.

Meanwhile, come to the DOS SIG in August and we'll share all the rumors floating around the system concerning Windows ME, 1G+ CPU's — and Reagan's paranoia.





Visual Basic - Beginning


