# **ON COMPLEXITY NUMBER 86**

[Editor's Note: This is the "real" #86. We, unfortunately, ran #85 two months in a row and are apologizing both to author Jim Hoisington and to our readers for the oversight.]

This is a tale of three software packages and the continuing saga of Windows 2000. I've been running Windows 2000 for about 11 months now. I switched from Windows NT because I wanted support for USB (Universal Serial Bus). The downside to Win2K has been the constant tweaking by Microsoft of its programming interfaces. When I applied Service Pack 1 (SR1), half of my purchased software packages quit working.


In the last month, I bought 3 software packages, all three of them from well-known vendors in the PC marketplace. This is the saga of trying to use that software with the Windows 2000 (Win2K) operating system.

# The Antivirus Software

My one-year subscription on the antivirus software was about to expire. Rather than renew the subscription, I chose to upgrade to the latest version of the software. I did this because the vendor had struggled throughout last year to keep their software working on the ever-changing Win2K platform. My expectation was that the latest package would be a fresh piece of code designed to work with the new operating system.

The installation of the upgrade failed with a cryptic message about some dll returning a value of -115. I checked with the vendor's technical support by e-mail and got an astounding re-





ply. To successfully install the upgrade, I had to manually delete the existing version of their software. The procedure printed out on 4 pages. It included deleting files, shortcuts and editing the registry to delete entries that referred to the earlier version of their antivirus software.

I followed their instructions and am happy to report that the upgrade then installed and is currently working (until the next Win2K update). But, editing the registry is not a procedure that I would expect to be able to install a piece of shrink-wrapped software that is sold in computer stores and office supply stores.

# THE UTILITY SOFTWARE

After reading a glowing review of a utility software package in PC World, I decided that it would make a useful addition to my desktop. I went to buy it but noticed that Windows 2000 was not mentioned on the outside of the packaging. I didn't buy it. When I returned to my office, I called the vendor and was assured that the product ran on Win2K. "They just haven't had time to update the packaging", I was told.

This vendor has supplied me with outstanding software over the years so I returned to Comp USA and bought the utility.

The installation went without a problem. But, when I went to use it, it hung the system. This is pretty amazing because I always felt that one **Continued on Page 7**

of the advantages of Windows NT and Windows 2000 was that they didn't hang. But this piece of software caused such a problem that Task Manager couldn't kill it and Shut Down couldn't kill it. I finally ended up powering off my machine. It's been several years since I've had to do that to get rid of an offending program. I tried using the software utility again with the same results.

I sent an e-mail to their technical support with a detailed description of what I was trying to do and what happened. Six days later I got a reply! The vendor apologized and said that the product was not ready to use with Windows 2000. They offered to refund my money.

#### The Microsoft Conspiracy

By now, you may be thinking that there must be some truth to the accusations against Microsoft in the federal courts. Companies are saying that Microsoft is keeping them from developing software products by withholding information about the programming interfaces while giving that same information to groups within Microsoft who are developing competing products. But, if you believe that, then you'll have to explain the third software package that I bought.

I bought a database package from a well-known PC manufacturer because they were offering a free version of the database that runs on the Palm OS. I think there is money to be made creating small databases on Personal Digital Assistants (PDAs) that synchronize with larger corporate databases. And, I have a proof of concept database project in mind.

I have a home theater and over the years have collected several hundred movies on VHS tapes, Laser Disks and most recently on DVDs. I'm going through my collection and upgrading all the movies I like to DVD. But, I'm at the point where I can't remember if I already own the movie on DVD. So, I'm creating a database on my desktop with all of my DVD movies and I'll synchronize it with an equivalent database on my Visor PDA. If it works, I can then use it as a demonstration of what can be done with corporate data on PDAs.

The desktop database software package installed without any problems. The manuals are well written and the tutorials are excellent at introducing the capabilities of the software. (The install program lets you reinstall the tutorials so you can repeat them if you need to practice.)

The database software appears to interface well with Win2K and with all the Microsoft Office products. It has a slightly different look and feel since it was written to run with a different oper-

> ating system and was ported to Windows. After using it for one week, I think it works and plays well with others.

I'm waiting for my Palm OS version of the database software to arrive. And, that will be the subject of another column.

# To Print, or Not to Print

At the March meeting, the Board of Directors visited most of the SIG meetings to get feedback. One question that was later posed to the entire membership in the form of a survey dealt with the cost of printing the newsletter, and by extension, ways to read the newsletter in order to keep the cost low.

At press time, we had received 19 responses. Very few of these had definitive overall costs for printing, although J. Dunn calculated his cost for b&w pages at 10¢/page, including amortization of the printer over 20 reams of paper. Paper cost ranged from about .01¢/sheet down to .002¢/sheet, plus ink costs which varied considerably. Printing cost is noted as being much higher if it was done in color, sooooo, don't print in color!! (Check the Printer Properties to force black & white printing on a color-capable printer.) Ink refill kits can lower the cost of ink as well. Of the responses, most printers were inkjet, although one was laser. Charles Fernandez, who teaches at DCCCD, said students are charged 5¢ for b&w pages and 10¢ for color pages.

J. Dunn & **Gene Brown** suggested buying paper at Fry's when on sale -  $99\phi$  per ream (500 sheets), or  $.002\phi$  each. "Regular" paper costs approached  $.01\phi$  each from other locations.

Worthy LaFollette offered this link at ZDNet: *http://www.zdnet.com/products/stories/re-views/0,4161,2645094,00.html* (live link on back page of this issue). This article compares the cost of operating various inkjet printers.

13 of the 19 responses indicated that they do not print the newsletter – just read it from the computer, and print only the necessary pages they want to file or carry. Two other members indicated they do print theirs, either because they like to mark up their copy, or because they prefer to read it while at work. The remaining four surveys did not state their preference either way.



**Fred Driscoll** said he copies his newsletters to CD to archive them.

Obviously, 19 responses cannot properly represent our 500 members, but it is a start, and suggests that the current electronic media is being accepted well. But keep those responses coming – we want to know how you feel we should proceed.

**Henry Burks** asked a good question in his response – "if the User Group is saving quite a bit by *not* printing and mailing the newsletter, should we be looking for reductions in our yearly dues?" The answer is "we would like to, but". The loss of meeting space at the Infomart effectively eliminated our ability to cohost the Vendor Show. Table rentals at the Vendor Show paid for all our Infomart space, and without that revenue stream, we have to rely on membership dues instead. We wish it were otherwise. This is also why it is extremely important to retain our existing membership, *and* to bring in new members.

**David Hall** pointed out that if we do remain with an electronic newsletter, could we revise it to better fit an entire page on the screen at a time to eliminate scrolling? This issue has been discussed in the past, but may warrant another review. We do send printed copies to sister User Groups around the country, and the current format is more conducive for that purpose. And for those members that do print, the product

### PRODUCT REVIEW - JIGSAWS GALORE

#### by Connie Andrews

Gray Design Associates has put together a powerful, award-winning shareware package in Jigsaws Galore Version 4.0. Jigsaws can range from 4 to 4,000 pieces so the software is suitable for use by all ages and playing abilities. The jigsaw preview screen makes it easy to find and choose a puzzle to play. With each puzzle you have a choice of five levels of both playing difficulty and size of puzzle, from default to custom. Pieces have a 3D appearance with a choice of "paper", "card", or "wood"

thickness. While playing a puzzle, you can change the size, shape, and "oddness" (a kind of distortion) of pieces. Pieces are fully rotatable.

The feature that absolutely hooked me on this product is the unlimited use of trays (popup windows) to group pieces or work on parts of the puzzle. You can use different trays to sort pieces by color or distinctive parts of the puzzle. You can also easily change the size of a tray to per-

looks near identical to what was previously received by postal mail.

If we had the resources, we would like to do both – retain the current format, *and* produce a "screen-friendly" version. By "resources", we mean members that are interested in stepping forward to make this happen. Unfortunately, we haven't seen a stampede of volunteers to date.

mit space to work on that part of the puzzle and then you can minimize it until you need the pieces. This frees up valuable screen space to work on the rest of the puzzle. A tray popup menu allows you a number of choices including arranging pieces within a tray, disarranging pieces, changing the size of pieces in the puzzle, and moving trays behind each other. Trays are automatically numbered starting with Tray 1, but you also have the ability to name trays so you'll remember what's in them (like "sky" or "water"). That feature would come in handy if you were working on an extremely complicated puzzle that you saved for later use. Of course, you don't have to use trays at all, but I can't imagine not taking advantage of this powerful tool.

There are cheat modes as well, including autosolve, hints, and fetch a neighboring piece. You can click on the Picture icon to view a picture of the completed puzzle and you can also activate a "ghost" image of the completed puzzle in the background to aid play. You can also change "skins" (background colors), dock your toolbars, print your jigsaws, and import various image file formats to create your own jigsaws.

There are sound effects and background music which supports MIDI, MP3 and WAV files. I

found the sound effects helpful in playing but turned off the music, which I found distracting. Perhaps if I'd had more time to explore the different music files, I might have found one that was soothing and conducive to play. You can also add your own music files.

I thoroughly enjoyed using Jigsaws Galore and highly recommend it to jigsaw lovers. However, I did have one problem. I could not activate any of the six buttons that allow you to change the shape of pieces. I sent an e-mail to Gray Design Associates requesting assistance and was very impressed that David Gray replied immediately. He wrote that they have recently become aware of the problem, which occurs on some machines running Windows 95B. They believe the fault is in a third-party component they use for these six buttons and that company is looking into it. They hope to have a fix shortly and will let me know when they do. Even without being able to change the shape of pieces, Jigsaws Galore is still a stunning program and great fun to use.

System Requirements: Pentium Processor, 32MB RAM, 4 MB Hard Disk Space, High Color or True Color Windows Setting, a Mouse and Sound Card.

Operating System: Windows 95/98/ME/NT4.0/2000 (but see comment above)

#### **Additional Review Comments**

Knowing that **Gil** and **Marilyn Brand** like jigsaw puzzles, I asked them to check out Zigsaws Galore to see if they could successfully change the shape of the pieces. Thought that was only fair to Gray Design Associates since they suggested I try it on a system that could do that. I also know that Gil is very direct and to the point, so I asked him for a review of my review hoping he and Marilyn would catch things I missed. And they did. Following are comments Gil sent by e-mail:

1... The game installed cleanly (something many games don't), but offered no choice on the Start-Menu name (minor).

2... It prompted for switching to their required 65536 colors (from my default of 256), and successfully modified the display settings.

3... We were able to successfully change the shape of the pieces.

4... Music did not work, but I have had other sound problems on this install of NT.

5... It crashed with a Dr. Watson (NT dump log) error several times when we attempted to close it. This too may be my NT system (old and unpatched except for critical security fixes).


6... Really like the tray feature.

#### April in Europe just beautiful this year

April is turning out to be an interesting month in spite of the The ARIETY STORE STORE A personal view of the PC industry New Hardware operating system software and application by Reagan Andrew

gloomy news from the tech stock community. For a change, the Europeans are providing a really spicy flavor to the news on two fronts—antitrust action against Intel, and causing US (American) Web-based concerns to squirm and attempt to wriggle out of rising privacy issues.

What American Web entrepreneurs are groaning and wailing over are much stricter privacy standards that the Europeans want the American sites to adopt. (There is also a "dark side" to the European Web effort, and more on that later.) To really appreciate the significance here, users have to visualize the Web as a worldwide, living entity that transcends national boundaries.

> Europeans often think of the US as a rowdy, undisciplined "wild west" composed of buccaneers, land barons, cowboys and Chicago-style gangsters all of whom probably carry guns and shoot up saloons. Some even have tattoos, chew tobacco and probably spit on the sidewalks. Hmmm May not be that far off the mark when thinking about some of the Web marketing types I've met in the past several years.

Remember, these American Web entrepreneurs are the same folks who have repeatedly claimed to the public and tried to convince the feds that no legislation in the privacy domain is necessary since the industry "will be self-policing" and that will be sufficient to protect consumers/users. Sure. And, I'll hire a fox to guard the chicken coop to assure future security. What the vendors don't want are limits to the use of customer data for their own benefit and profits.

Selling personal data is a very, very big business with potential for immense profits to the vendors. Fact that they are profiting from further exploitation of their own customers in a manner that most (users/customers) would never allow (if asked) or condone is irrelevant to those who stand to reap those dollars/pounds/Euros/DM, etc. A lot of these folks need to take a review course in Business Ethics (if Marketing and MBA programs still teach such courses.)

I'm beginning to wonder. For those who don't know, most European governments have long memories of the use to which personal data can be exercised in interests other than those of the individuals. One of the major pressures for "Privacy" came from the American government at the end of WW-2, when everybody (I think) was highly sensitized to the more sinister uses in which such lists were employed.

Computers make it all too easy to gather, collate and create personal dossiers that might be used for marketing—and other, less sanguine purposes. Am I being paranoid? Last year, I would have answered in the affirmative. Now after hearing some of the more self-serving claims of the folks most interested in preventing any regulation of the industry in terms of personal privacy for the last several months, I don't think I was sufficiently paranoid

I mentioned a "dark side" earlier. The Europeans also have strong concerns about Web content and certainly endorse the concept of "state-approved" censorship of material available to their citizens. Germany has probably been most active in this role lately, pressuring some services to "block" availability of Nazi data and war souvenirs. We, on the other hand, endorse the concept of the Web as a bastion of free speech (except for child-related pornography) and abhor the concept of censorship.



#### INTEL RUNS AFOUL OF EUROPEAN CPU 'CHOICE' CONCERNS AND HITS ONE MORE ANTITRUST SUIT

Europe (and another antitrust suit) supplied yet another mention as Intel was named as using anticompetitive trade practices to discourage vendors from using non-Intel CPU's in machines sold for the European markets. Seems the Europeans watched the American DOJ investigation of Intel with somewhat more probing concern and decided that the giant American CPU vendor was in fact pressuring vendors to become "Intel Inside only" shops and forego the competitive CPU's available for less \$\$\$ than the Intel brand.

How this works is relatively simple. PC makers want the fastest, "premium" CPU's for their top line machines. Intel has them (so does AMD), but "discourages" vendors from using much less expensive (slower) CPU's for their economy PC's. "Priority" for obtaining the newest, fastest, etc., CPU's may be inferred as a function of using the Intel CPU's throughout the vendor's PC lines. (OOPs, forgot VIA Technologies of Taiwan here. Seems VIA is producing ever-faster x86 CPU's based on Cyrix technology that may also be a "player" in the European PC market.)

Those vendors who use alternative, less expensive, CPU's in their lower tier machines may discover they are much lower on the priority list than all-Intel Inside vendors.

Profit margins are razor thin in the PC business and loss of "premium" timing may create a situation where the vendor suffers significant loss of sales of the high-end, much more profitable PC's.

This was certainly a factor in the past, but may not be so important now.



Reason I question this now is the reported "shift" in the larger IT departments away from the very high-end hardware unless there is a demonstrated need for the speed in typical operations. I think this is reasonable—and refreshing for a change. I can remember a time when the 386 PC's were initially coming into the market, and usually wound up on the desk of a department head and were rarely used for anything except reading e-mail. Workers with a need for the increased capabilities tended to be much further down on the totem pole in spite of their obvious need for the power.

Intel prevailed against the DOJ, don't know how they will fare under the European microscope. Since the most competitive CPU vendor (AMD) is also American, think this may also fade into the sunset as it did in the DOJ case.

#### Another fillip from Germany: German publishers sue Fujitsu-Siemens in 'royalties' affray

This one may lead to lots of fun—for me. Seems that a German publishers' consortium, VG Wort, is suing the country's largest PC maker/vendor, Fujitsu Siemans, for "potential' copyright infringement. Although it seems a little flaky from the outset, suit is deadly serious in intent.

What they are asking for is a front-end payment of the equivalent of \$27 per PC according to a recent article by Brandon Michener in *The Wall Street Journal*. Germany has had similar levies on tape recorders, video recorders and photocopiers since 1965 he wrote.

The consortium of 220,000 authors and 5,500 publishers claim that the PC's being sold by Fujutsu-Siemans will be used to copy and thwart copyright works of their authors and publishers. Had similar claims laid against Xerox in the US in the past by several publishing houses in the (remote) past. Problem is that PC's, CD/ROM burners, etc., make copying of copyrighted material very easy.

My problem here is that suit also assumes that PC users are inherently dishonest and will do anything to get around copyright protection. That's the rub. An assumption that the PC user is basically a crook who desires to steal material from the consortium. Recent moves with MP3 and the Internet may add some emphasis to that opinion unfortunately.

On the other hand, I can appreciate the concern. I'll use myself as an example. I have approximately 400 old, much cherished, LP's gathered while I lived in Germany, courtesy of the USAF. I'm in the process of converting these to CD's. Since I still own the actual records, is my effort to prolong their life via recording to CD a copyright infringement? I don't think so, since I still have the originals.

If I were to sell the original LP's and continue to play the CD's for my own enjoyment—yes, it probably would be seen as such. However, do I owe a consortium of authors and publishers a 'royalty' fee for any material I may copy to preserve the originals over time? I don't think so. Again, I'm not European and my opinion(s) count for little in their courts.

#### South Korean unit responsible for Belgian speech recognition Software publisher's problems?

Once upon a time, Lernout & Hauspie (L&H) ruled the speech recognition realm for PC users. Its different now and future of the publisher of *Naturally Speaking* is in considerable doubt since filing for Chapter 11 bankruptcy protection in November 2000.

Accounting firms are at center of the issue with suits and counter-suits flying over the financial debacle created by L&H's South Korean unit, apparently in collusion with several Korean banks. Described in the April 6, 2001, issue of *The Wall*  *Street Journal* article by John Carreyou and Mark Maremont, the activities of the people and banks at the Korean unit involved in bringing L&H to its knees are somewhat familiar. Basically it was fraud on a massive scale that went undetected by L&H's (then) auditors, KPMG, but was exposed in a probe conducted by PricewaterhouseCoopers (PWC) and reported in *WSJ*. Byzantium was never this corrupt.

Essentially, the Korean L&H unit was reporting huge, but bogus, sales of software. Local officers were receiving \$millions in bonuses and incentives, the Korean banks cooperated in the scheme and L&H wound up with approximately \$127 million less money than it thought it had.

KPMG has since sued L&H charging the Belgian firm actively obstructed KPMG's efforts to perform an accurate audit of L&H. This may be fun over the coming months and tickled some old memories.

The PC industry saw a similar, but much smaller scale, effort in the disk drive industry a number of years ago. A hard disk drive maker (long gone) was caught reporting large-scale deliveries of its drives. Investigation of these claims revealed that most of the "drives" were actually bricks wrapped up to give the appearance of finished product.

#### 2 GHz CPU's by 2002? INTEL will RELEASE 1.7 GHz PENTIUM 4 IN LATE April

April 23, 2001, is set as the release date for Intel's new 1.7 GHz Pentium 4 (P4) CPU, leaping ahead of AMD again in the high speed CPU race. Media sources continue to question the P4 architec-



ture and several report that AMD's Athlons are actually somewhat faster than the P4's in many applications. AMD recently announced release of a 1.33 GHz CPU as well.

Main drawback to the AMD Athlon line is higher heat produced by the high-speed CPU's which tends to restrict CPU speeds as a result. If you look at the heatsinks required by the Athlon Socket A CPU's, you would get some appreciation of this fact. Plans by both Intel and AMD to move to even smaller chip trace sizes may reduce the amount of "waste heat" generated by the CPU's.

What may be more important to most of us, both Intel and AMD have announced price cuts on their CPU lines effective in April. That may raise the CPU "sweet spot" one more time, perhaps to the 1 GHz level CPU's. Am seeing several vendors advertise 1+ GHz Athlon/ motherboard combos in the \$250 - \$350 range over the last week.

#### Endings...

It's official—I'm now unemployed, oops, retired. Don't know if I chose the best time to give up federal employment, yet, but did feel it was time. Interesting was a headline in the *Dallas Morning News* on Monday, April 2, citing the new fears people planning early retirement are experiencing now. Unfortunately, I read that as I was leaving for the VAMC Dallas to "clear station."

Gene Brown (of Gene's Photos in Gainesville, Texas) shared his experience and techniques for "Successful Scanning" at March's Dallas Corel SIG. His perspective, as a professional studio photographer, brings unique insight. From photo restoration to traditional wedding photography to printing from digital files, he does it all. For an excellent book on scanning, Gene rec-

ommends Real World Scanning and Halftones, 2nd edition. You can pick it up at a local bookstore or order from http://mail.ntpcug.org/asp/signotes/www.amazon.com (live link on back page of this issue). Gene's presentation started with his purchase decisions for optimal scanner-computer configuration and a review of basics to help us understand scanner optical resolution, dynamic range and bit depth. While scanners usually come with proprietary software, a generic one by Silver Fast at http://www.silverfast.com/ (live link on back page of this issue) gives professional results. He took us through the decision steps in the scanning software interface. Stressing the importance of starting with a good scan, first use the scanning tools to get the best image information possible. Then tweak it in an image editor like PHOTO-PAINT to correct further. To retain highest quality, make the image adjustments in the image editor's native file format and output to a JPEG as a last step. Gene usually scans at 360 dpi, since that's a multiple of his Epson 3000 printer's output. Calibrate your monitor and printer for predictable results. His printer paper of choice is Red River Paper Company's 53# photo gloss. He projected photographic images onscreen to demonstrate the same image's appearance at different gamma settings. Then he used the level equalization, color curves and color balance tools in PHOTO-PAINT for further adjustments to reach the best and final result. What a valuable session for all in attendance! #### **DOS / Operating Systems**

It's Spring, 80+° and my tireless editor/proof reader and priceless wife, Connie, is helping get another issue of The PC News out to NTPCUG members on her birthday. That's dedication. Looking ahead to Summer—and the coming release of Windows XP—I'm hoping the new Windows lives up to at least half of our expectations. I'm looking forward to stability and fewer (many fewer) re-boots with the new release.

I'm also looking back to my experiences with Win 9x over the last seven years (I'm including the *alpha* and *beta* experiences as well) and the massive improvements over Win 3x that Win 95 brought to users. Real multi-tasking for one and real networking for another.

Example: I have *MS Office* loaded on my main working PC. I have a "back up" PC I use primarily for scanning and image manipulation that is powered by an AMD K6-2 at 550 MHz and equipped with 50 GB of hard disk space. Although I could have loaded Office on this machine as well, what I did do was bring icons for *Word, Excel, Access* and *PowerPoint* across the 10Base100 network and install them on the back up PC Desktop. All load quickly and operate as if they were installed on the back up PC instead of coming across the home network.

I'm not too sure Microsoft would consider this "legal," but it works well and I never have both copies of the Office programs operational simultaneously. However, I could open several instances of Word on one machine without breaching the single user license so I would hope that doing this across the two machines I operate on the home network would be seen as the same.

Licensing can be problematic when users think about it. I have multiple copies of Win 95, Win 98 and Win 98SE purchased over the last five years. I also have a copy of Win 98SE Upgrade for Win 3x and Win 9x as well as two copies of Win NT 4.0 Workstation and one copy of the Win 2000 Workstation upgrade. At home, between Connie and me, we usually have four operational PC's connected by a home network. I don't mind upgrading (to gain stability), but looking at cost of MS Win XP times four is a little daunting. Especially since I retired from the VA a week before this is being written (on the same day The Dallas Morning

*News* ran a headline on the first page: "Planning early retirement? Not so fast, market says.")

It does make LINUX look a little more promising and a lot cheaper—with exception of replacing a lot of application software and keeping the system maintained properly. However, Corel is porting the *CorelDRAW 10* suite and *Word-Perfect Office* suite to LINUX which could save some major \$\$\$. Hmmm After all the 'tacky' things I've said over the years about WP, this could be a source of some embarrassment.

#### Internet – Beginning & Advanced

In March, we had two formal presentations. At 10:00 AM, the Beginning Internet SIG began a discussion on "Search Engines." We discussed the types of search tools available – individual sites such as Google and AltaVista, and Metacrawlers such as Dogpile that pass your request to multiple search engines and return their collective results. Some Metacrawlers remove any duplicate entries seen by all the search engines – others present it to you "as is". But at least with Metacrawlers, you don't have to go to each site individually.

We also discussed various "tricks" that can make your searches more effective. These include use of plus and minus signs to indicate what search terms MUST be present(+) or absent(-) before a Web site is included in the search results. Boolean search terms (AND, OR, NOT, NEAR, and nesting) were partially covered. If you have a phrase in mind, such as "user groups", put it within quotes to indicate that a Web site must have those words in that order to be chosen in the search.

For those not familiar with the search engines, there is a good Web site at *http://www.searchenginewatch.com* (live link on back page of this issue) that explains them. It has tutorials, links to Search Engines, comparisons of Search Engines, details on Boolean Searching, etc). We suggest you look it over to learn more about Search Engines.

In March's Advanced Internet SIG, Ms. Maria Wiemann presented "GroceryWorks.Com," the Web-based grocery shopping & delivery service that most of you have heard about. Maria did a fine job demonstrating how it all works, how it can benefit you, and even brought along LOTS of Altoids and \$15.00 discount coupons as giveaways, plus some tee-shirts. Apparently, this was a topic of significant interest – we had a good attendance and very few left early.



In April, we would like to continue talking about Search Engines in the **10:00 AM Beginning Internet SIG** for at least part of the session. We are still interested in what Search Engines you like - bring them with you and we will discuss.

#### **Cheating Is Encouraged!**

Although these answers were originally planned for the March meeting, since I included the questions in last months newsletter, I'm including the answers this month ... just to be sure they don't get lost in the shuffling of the meeting topics. Were you able to identify the answers to:

1. Ensure that only certain people can modify my document. [Tools | Options | Save | File-Sharing Options ]

2. Set up Word to perform a temporary backup every five minutes. [Tools | Options | Save | Save Auto Recover info every x minutes]

3. Increase the maximum number of files listed at the bottom of the File menu. [Tools | Options | General | Recently used list file

4. Keyboard shortcuts to Open, Close, Save and Print Documents. [*Ctrl+O*, *Alt+F4*, *Ctrl+S*, and *Ctrl+P*]

5. "Close All" documents with one command. [*File* / *Shift*+*Close*]

6. The feature that maintains a record for each document, including a descriptive title, the author's name, the subject and keywords identifying topics or other information. [File | Properties | Summary].

Wow, I Didn't Know That!

#### **Understanding Smart Cut and Paste**

Word includes a feature that, by default, tries to make your editing just a little easier. This feature, called Smart Cut and Paste, adds or removes spaces when you are cutting or pasting text. This may sound odd, but it is really helpful in many situations. For instance, if you are pasting a word into a sentence, Smart Cut and Paste makes sure that spaces are added around the word so that it does 'run in' to the words you are pasting near.

Likewise, when you cut a word from a sentence, sometimes the cut might result in two spaces left: the ones that used to surround the word being pulled. Instead, Smart Cut and Paste results in one of the spaces being automatically deleted so the resulting sentence has (at least) the proper number of spaces in it.

You can control smart cut and paste in the following manner:

1. Tools | Options | Edit

2. Set: Use Smart Cut and Paste check box as desired. If selected, the feature is turned on; if not selected, it is off.

3. OK.

Although these topics may seem somewhat basic to you, it is guaranteed you will gain new insight and timesaving shortcuts, as well as learn about features you did not even know existed.

Stick with us and by the end of the year, we will have worked our way through printing, page formatting, character formatting, paragraph formatting,





tabs, tables, headers and footers, page numbering, section breaks and even into styles!


