

Acronis True Image 8.0 Review



Short Summary: If you're looking for reliable, easy to use software to manage backups and transferring data to new hard drives then Acronis True Image 8.0 is an outstanding solution. Whether you are working in a Windows or Linux environment, True Image is a cost effective solution to disk recovery.

About the Company: Acronis offers storage management solutions that are technically advanced but easy to use. The company provides disaster recovery, backup and restore, partitioning, boot management, privacy, data migration, and other storage management products for enterprises, corporations and consumers of any qualification. Their website is:

The Acronis Website says that True Image 8.0 is award-winning disk imaging software. At first, I was skeptical as what would make this software anything special. My first question to research was to find out exactly what makes a disk imaging software different from a plain backup utility. What I found was True Image 8.0 contains a rich set of functions that include: complete and incremental backups under Windows (with no re-boot), a Scheduling utility for automatic backups, creation of a boot CD from your current system configuration, verification of backup images, creation of an exact clone from one hard drive to another (including expanding the partitions when you want to move to a larger drive), and a wizard to help you automatically deploy a new drive as additional storage. There are also a couple of other features that did not get tested in this review such as creating an Acronis Secure Zone (a separate partition) for your backups and the ability to completely wipe your old disk.

Acronis True Image 8.0 works on *Windows 98 / Me / NT4 / 2000 / XP*. The user group discount price is \$34 and is available from User Group



Relations at: <http://www.ugr.com/backup.html> or from the manufacturer at as a download for \$49.99 or as a CD (with an additional charge for shipping).

Minimum System Requirements:

CPU: Pentium 133 MHz or higher

RAM 128 Mb or more

Disk space: 20 Mb

The CD I received from User Group Relations had a manual on the CD but there was no printed instructions with it. After talking with Gene Barlow of User Group Relations I printed and read the manual and Barlow's article, "Using Acronis True Image 8.0" at <http://www.ugr.com/nl1024.html>. This made the installation and use of the software fairly easy. I recommend you do the same to understand the complete functionality of this software. I also recommend developing a backup process which is mentioned in two excellent articles: "Backing Up your Hard Drive" and "Perfect Backup Approach" at www.ugr.com.

Users of this software need to be familiar with the terminology of formatting drives such as 'partitions' and need to be comfortable connecting new hard drives into their system. For this

reason, True Image may not be appropriate for novices. However, if you are not comfortable with an internal disk drive, there are external drives available mounted in a case that attach to your computer via a USB connector.

True Image’s installation process is fairly standard for PC software. However, during the installation wizard you will be asked if you want to create an Acronis Secure Zone. If you do create this ‘Zone’, True Image will create a hidden partition on your main hard drive where you can save all of your image files. Gene Barlow recommended that you avoid using the Acronis Secure Zone so I did not bother testing this functionality.

The wizard also asks if you want to create a bootable rescue media to use in case your main hard drive should fail. If you are going to immediately update to a new version of True Image, then say ‘no’ the first time you run this software. After updating the software **then** create the rescue CD so that you can restore an image without having a working operating system.

Creating a rescue CD was the first item I tested. This particular functionality caught my interest because my latest systems no longer have a floppy disk. I only have a USB floppy that I dig out for reading files when I just absolutely have to use it. Also, my experience with Norton’s Ghost and other backup software made me skeptical that anyone would truly be able to make a bootable CD for **MY** system. I have just upgraded to an AMD Athlon 64-bit CPU on an Abit N8 motherboard with a Gigabit Ethernet on-board. The CPU and the Gigabit Ethernet both need special drivers. Not only did True Image make a bootable CD, it performed flawlessly when I tested it. Later in the week it

saved me lots of time [more on this later]. If you do not have a CD writer be prepared to have plenty of formatted diskettes to use if you make the recovery disk.

After starting True Image there are icons for all the major functionalities. I immediately decided to take a full image backup to a DVD. The ‘Create Image’ Wizard showed 5.87 GB **used**. The standard Windows File Explorer shows that my C: drive had 24.4 GB **free** out of a 30.2 GB partition. This took me a little while to get used to seeing the amount used as opposed to the amount free. In the wizard, I was very happy that there were check boxes to select either individual partitions or the entire drive.


True Image had no problems with me having several partitions on each drive and having more than one drive. There were choices to be made about where to place the back-up image and the size of the image to be generated. I recommend the ‘Normal’ setting for compression which has the best trade off between the size of the backup image and the time it takes.

I had no problems making images of various sizes using CDs as well as formatted DVD+RW disks. An appendix in the manual indicates that DVD+R disks could be used but they require special software (Roxio Drag to Disc).

An unexpected True Image function is the ability to browse the created compressed images.

This allows you restore one or two files from an image on a hard drive! This can come in very handy when you clobber a file. I expected that the image generated could be verified upon completion but having this image browsing capability was a nice surprise.

Another feature I appreciated was the automatic calculation of how many disks



would be needed. This allowed me to format enough DVD+RW disks ahead of time. I can't count the number of times I have been just one disk short with other programs! The one confusing message that I saw during this process occurred after filling the second DVD disk. The program told me to label it with a number larger than two. I figured out that True Image breaks the disk image into pieces. So, for instance, it broke mine into 2 GB pieces. The first disk contained pieces one, two and three, disk two contained pieces four, five, and six, and disk three contained piece number seven. When True Image ejected the **second** disk it told me to label it with the 'piece' number rather than the disk number. If you're backing up to a hard drive you will not encounter this confusion since the program will automatically handle the numbering in the file name.

Next in the testing, I scheduled an automatic incremental backup and configured it to run daily. This feature worked as advertised. True Image produces nice log file entries and even handled having the system not being up when it was supposed to be making the backup. Later during the week my system crashed. (This was not related to this software but some driver problem that has been plaguing my system since upgrading to the AMD 64-bit CPU.) When I tried to bring the system back up, it failed to boot. I immediately booted the True Image rescue CD and proceeded to restore the C: drive using the full image backup DVD that I had generated the previous day. The system came back up with no problems! This was certainly **not** planned to be part of the testing I did for this review.

The next test was the disk cloning. For new disk deployment there are two choices on the main menu, 'Disk Clone' and 'Add a new disk'. 'Disk Clone' will copy the disk image byte for byte. The 'Add a new disk' is a wizard and gives you the option of moving the image on-to a disk of a larger size. The program will automatically calculate a proportional size for the partitions. If you



want to control the size of the partitions entirely, you will have to make a full backup of each partition and restore each partition separately.

In my test I cloned an 80 GB hard drive to another one of approximately the same size. (Each manufacturer maybe slightly different even though they are advertised as an 80 GB hard drive.) I also cloned a Toshiba notebook 40 GB drive to a 60 GB drive. The 80 GB clone worked fine, the Toshiba notebook drive was more difficult. This had nothing to do with the drive or with the True Image software, but rather it was related to running on the Toshiba notebook. On the notebook the clone operation appeared to just stall and gave sector errors on the drive. Finally, in order to get the clone to work, I created images on 3 DVD+RW disks. Then I took them to my desktop system where I plugged the notebook drive into an adapter and into the USB ports (it takes 2 USB ports to power the connector). This worked fine although the process of changing the partition size makes the cloning step take longer than the byte-for-byte clone.

Overall, I was very impressed with the quality of True Image 8.0. It combines several utilities that are sold separately by other companies. It was more reliable than **Acronis True Image 8.0 Ctd...**

FrontPage 2003

Over the years that FrontPage has been around, I have picked it up and put it down three times. This report tells what happened when I picked up FrontPage 2003 and tried again.

I've been tempted by each new version of FrontPage because it makes many tedious and

Norton Ghost and didn't place as many hooks into the operating system as GoBack.

I was very surprised that the software will also clone Linux disks. True Image flawlessly recovered my C: drive after a hardware-related crash. If I had only had this software a few weeks ago, I would have saved many painful hours of reloading Windows XP and all my application software after a similar crash!

For the intermediate to experienced PC user, read the articles listed above and the manual and you should have no problems running True Image. More importantly you'll have the piece of mind that you can recover your system **when** problems occur. Remember there are two kinds of PC users: those that **have** had a disk crash and those that **will** have one! For backup and cloning of disk drives, I heartily recommend True Image 8.0.

complex Web site development tasks very easy to do. All that power to crank out high quality, high function Web sites has lured me to try again and again.

For example, FrontPage generates very attractive Web pages. It comes with a large set of esthetically pleasing style templates, artwork, and fonts. It also has an easy-to-use WYSIWYG editor that allows you to precisely place text and graphic items on the Web page. If you change your mind, it is easy to switch templates and experiment. The FrontPage 2003 page editor is better than ever, and supports all kinds of drag-and-drop items that greatly simplify creating and using Web forms and updating databases.

But FrontPage is not focused on creating individual Web pages; its purpose is to help you build and run Web sites. For simple Web sites, that is good news. It means that someone without much training can quickly design, develop, and publish an attractive Web site. FrontPage 2003 provides many ready-made solutions; you just pick the one closest to your needs, customize it to look the way you want, and plant your flag on the Internet.

Although the template and wizard approach can get you up and running quickly, the FrontPage developers I've talked with say that the more complex a Web site is, the harder it is to use templates. Unfortunately, the templates are not customizable and do not scale well. My own experience is that templates make for a great demo, but are not usable for many Web applications.

So if you are going to have to get down and dirty to use FrontPage for non-trivial Web projects, just how good is FrontPage as a Web site programming tool? My conclusion: *FrontPage does not want to be a tool; it wants to be the solution.*

NTPCUG Volunteers have assembled, tested and shipped their **1,500th** PC since the project began. Currently, the volunteers are averaging 500 refurbished PC's for impaired users per year.

For new members, NTPCUG sponsors a volunteer program to refurbish "old" PC's using NTPCUG volunteers with the finished computers going to visually impaired individuals via the Texas Center for the Physically Impaired (TCPI), <http://www.handicapability.org>. All of the equipment goes to blind or visually-impaired persons in America and in several foreign countries.

If you have basic hardware skills, or just want to learn, contact me at gb1@ntpcug.org We only have 12 work stations, so please request a place. Don't just arrive expecting to find a station available.

We have regular sessions every Tuesday and Thursday, 1-4PM, at King of Glory Lutheran Church, 6411 LBJ Freeway (West bound serv-



ice road from the Hillcrest exit). Our workroom is in the basement level of the church. Ring the outside bell for entry into the building.

If you, your employer, or a friend, have older computers (Pentium II-300Mhz or better) and/or components (56k-modems, hard drives, sound/video cards, 72 & 168-pin memory, monitors, keyboards, mice) that are just gathering dust, please contact me about donating them to this tax-deductible effort. We have received several corporate donations in the last few months; PLEASE keep checking with your company about donations.

We are also in need of a couple of volunteers to assemble some donated shelving, if you can't or don't want to work on computer hardware.

And last, but not least, we need a volunteer to: determine the proper driver for various donated sound/video/modem cards; download and test the drivers; and save the drivers to floppy disks.

So you can see that we need volunteers with different skills, and have a continuing need for additional computer refurbishing help. Let me know if you can assist.

[For those of you who have requested weekend sessions, these do occur on occasion and if you let Gil Brand know of your interest, he'll get in touch to let you know the date and times.]



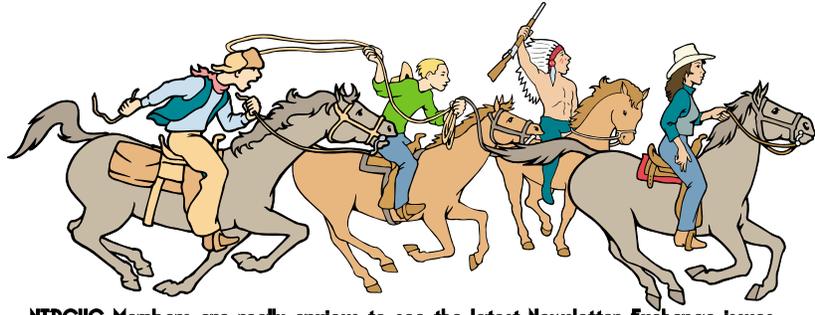

If you have a friend or relative who constantly "borrows" your copy of the latest *North Texas PC News*, a gift membership might be especially welcome.



Access

Regular attendees will get a good grounding in Microsoft Access, with perhaps an occasional diversion of product demonstrations or advanced topics -- it will be great introduction if you are just starting or a great review of topics for the more experienced user. No matter how long we use this great database software product, there is always more to learn about using it effectively, efficiently, and easily.

On June 18, 2005, the topics will be those originally planned for May: We will continue with our review of the fundamental operations and features of Microsoft Access -- this month's topic will be Access Lookup Tables and SELECT Queries, presented by Microsoft Access Fundamentals SIG Leader **Jim Wehe**. See the Access Fundamentals SIG Notes for details.

Our May presentations were interrupted because of 'technical difficulties beyond our control (construction work at the college)', resulting in room reassignment out somewhere in the 'North 40' and lack of a projector. We did however, have our regular monthly drawing for a full, retail copy of Microsoft Office 2003 Professional.

Alpha Five Database

The 2005 Alpha Software User Conference was held last month in Boston. Several of the SIG members were there to hear the news of the upcoming Alpha Five version 7 and Alpha Five version 7 client/server releases. Among the many new features of both the desktop and web interfaces are Portable SQL and a javascript navigation system.

Alpha users have always had very easy ways to access and query data. However with greater emphasis on using data in its native format, SQL is required for many data sources. Portable

SQL is a standardized SQL syntax that Alpha created for use when connecting to data sources that use differing SQL syntax. Alpha then translates the Portable SQL into vendor specific SQL. Of course, SQL native to the data source can also be used. Familiar query builders can also be used to create syntax in either the portable or native versions.

One of the new web component types in Alpha Five version 7 is a navigation system. By simply specifying cascading menu items and corresponding urls, a javascript menu is created for your web page.

This month the SIG will review the development direction that Alpha Software is taking, and answer questions that you may have on migrating your existing applications to the current Alpha Five release.

If there is time we will also continue with the discussion of our web application for storing and reporting SIG notes.


A recent online survey revealed that 34% of WiFi networks have no security enabled. The breakdown for this survey was 22% hiding SSID, 22% WEP (Wired Equivalent Privacy) and 22% WPA (WiFi Protected Access). WEP is an encryption system for data that 802.11 sends over the air. WEP has two variations: 64-bit encryption (really 40-bit) and 128-bit encryption (really 104-bit). 40-bit encryption was the original standard but was found to be easily broken

There are no straightforward ways of implementing wireless security out of the box. Manufacturers of WiFi products want products to work when powered on. After all, that \$60 wireless router may have been sold by the manufacturer for \$25. So the WiFi manufacturers want the product to work out of the box. The manufacturer does not want to create support situations.

If you spend \$60 for a product and you need phone support, at \$60 your good deal has become a disappointment. Sometimes, the support staff learns from the assistance but the user may not. Even e-mail support requires manpower. Wireless is new, changing and the terminology is not standardized. The security is included but the process of securing the product may cause it to stop communicating.

There are some changes in the wireless world. Intel will display a prototype of a WiMAX base station next week at the 2005 Supercomm event (). WiMAX will operate on the same frequencies as 802.11b and 802.11g.

I do envision a citywide commercial application for WiMAX in a different frequency spectrum. Companies are taking a second look at the 802.11a standard. The advantage of 802.11a is there is no interference from microwave ovens in the break room, 2.4 MHz cordless phones, Bluetooth phones and headsets.

Most buildings were built before WiFi was conceived, so there was no consideration for obstacles that block and interfere with wireless signals. Also, 802.11a hasn't been adapted for PDA's because of the increased heat and power requirements. There are also less retail products to locate and connect to 802.11a networks.

The downside to 802.11a is employees who travel or commute need to have both cards. 802.11a is more expensive, the signal range is lower than 802.11b & 802.11g, but the reduced interference translates into higher networking speeds.

We will discuss security and the wireless standards in our June SIG.

JUNE — Paragraph Formatting, Part I
 Do you know the secret that the paragraph symbol at the end of each paragraph holds? Is indenting text a trial-or-error event? Want to know a shortcut for changing line spacing to double space or space-and-a-half? Understanding Word's logic about paragraph formatting is one of the most important aspects of Word.

JULY — Paragraph Formatting, Part II
 Line spacing *within* paragraphs is usually single- and double-spacing. You can, however, change it to any amount of spacing. Spacing *between* paragraphs is normally one line. This, too, can be changed to have it added automatically when you end a paragraph!



Indenting and keeping paragraphs together will no longer be confusing to you after Paragraph Formatting, Part II.

AUGUST — Paragraph Formatting, Part III

The Format Painter is one of my favorite features; I use it with almost every document to speed up formatting. A similar secret weapon enables me to supplement the Format Painter. The remainder of our session will cover Paragraph Borders and Shading.

 The most valuable help within any reference book is the index. Creating an index may be more than you have been willing to tackle alone. You will leave this session with the confidence to index your own documents, as well as an introduction to one of Word's field codes. Sounds scary, but it isn't.

JULY — Table of Captions *for* Figures, Tables, Graphs & Equations
 If your document contains numerous figures, you may also want to have a list of those figures at the end of the document. When you create a Table of Figures, the captions are selected, sorted, and placed in a table. We will create captions for the figures, and then create the Table of Figures.

Creating Stronger Passwords

If you've ever lost your wallet, you know the sense of vulnerability that comes with it. Someone might be walking around with your identification, pretending to be you. If someone stole your passwords, they could do the same thing online. A hacker could be opening new credit card accounts, applying for mortgages, or chatting online disguised as you—and you wouldn't know it until it was too late. Read on to learn how you can help protect your identity online by creating stronger passwords.

Are you using weak passwords?

You probably already know not to create passwords using any combination of consecutive numbers or letters such as "12345678", "lmnopqrs", or adjacent letters on your keyboard such as "qwerty." And you've probably heard that using your login name, your spouse's name, or your birthday as your password are also big no-nos. But did you know that you should never use a word that can be found in the dictionary, in any language? That's right. Hackers use sophisticated tools that can rapidly guess passwords based on

words in the dictionary in different languages, even common words spelled backwards.

If you use a common word as your password, you might think you're protected if you replace letters of that word with numbers or symbols that look like the letters such as M1cr0\$0ft or P@ssw0rd. Unfortunately, hackers know these tricks too.

Step 1: Create strong passwords that you can remember You could come up with a completely random combination of numbers and symbols, but that's not very practical. How would you remember it? Chances are you'd write it down and keep it in the top drawer of your desk and then it's no longer such a great password after all.

A strong password is one that is at least eight characters, includes a combination of letters, numbers, and symbols and is easy for you to remember, but difficult for others to guess.

Create a strong passphrase

The easiest way to create a strong password that you won't have to write down is to come up with a passphrase. A passphrase is a sentence that you can remember, like "My son Aiden is three years older than my daughter Anna." You can make a pretty strong password



by using the first letter of each word of the sentence. For example, msaityotmda. However, you can make this password even stronger by using a combination of upper and lowercase letters, numbers, and special characters that look like letters. For example, using the same memorable sentence and a few tricks, your password is now M\$8ni3y0tmd@.

If you still think that's too hard to remember, you could try a more common phrase, such as "You can't teach an old dog new tricks." If you're using a common phrase make sure to inject at least one number or symbol into the password. Such as U(t@0DnT.

Step 2: Keep your passwords a secret

Keeping your passwords safe means keeping them a secret. Don't give them to friends and don't write them down and keep them at your desk or in an unprotected file on your computer. Your house could get broken into, or more likely your child may give a friend access to your computer or your desk and that friend may not have the best motives when it comes to your privacy.

Even if you know not to write down your passwords or give them away to friends, you should also be wary when giving them to the Web site where you created the password in the first place. A new way in which hackers trick people into giving away their passwords and other personal information is through a scam called "phishing." Phishing is the practice of sending millions of bogus e-mails that appear to come from popular Web sites like eBay or Amazon. The e-mails look so official that many people will respond to requests for their login name and password.

Microsoft, eBay, Amazon, PayPal, or any other reputable company will never ask you to send your password through e-mail. If you receive a request for your password, social security number, or other sensitive information via e-mail, notify the company immediately by phone or through their Web site.

Step 3: Manage your passwords

The safest password technique is to create a new, strong password for every

Web site or login that requests one. This is almost as impractical as remembering a long string of random characters. An easier solution is to create a handful of strong passwords and use those at sites you want to keep most secure, such as your bank, brokerage, or bill paying company. Then create another small set of easier to remember passwords that you can use everywhere else.

Remember, a strong password is one you change every few months. Just as you make a date with your computer to run updates, backup software, and clean out old programs, you should also regularly change passwords.

Step 4: Monitor your accounts

Creating stronger passwords can help protect you against identity theft. However, it does not guarantee that you are protected. If someone does steal your passwords, the faster you catch on and notify authorities, the less damage a hacker can do. Make sure to monitor all your monthly financial statements, and call the appropriate company or bank immediately to report issues. Also, review your credit report each year.

Next steps to protecting yourself

Identity theft can happen if someone steals your password, but there are other ways for hackers to break into your computer. You can continue to improve your computer's security by keeping your software up to date and using a firewall. To learn more, visit our Protect Your PC section.

In case you are wondering how, it's fairly easy to accomplish via the BIOS support chips. 

two Footers in a document simultaneously. In my 20-some years of using WordPerfect, I have never needed more than this. Yet, you can replace any of them with a different one as many times as your document requires. And, discontinuing them is only three clicks away.

5. At *Layout/type properties*, choose style and appearance options for your chart
6. Chart | Series
7. At *Series properties*, choose line and fill colors
8. To return to the document, click outside the chart

FrontPage 2003 ... Ctd.

That is the source of my continuing frustration with FrontPage, and it's why I've tried and quit using previous versions. To use FrontPage effectively, you must understand and agree to use the framework of the Web site it generates. If that framework is a good fit for the Web site you want to build, FrontPage is the right product for the job at hand. Just remember that FrontPage is not a tool, it is an architecture and a methodology.

In fairness, I must say that FrontPage 2003 is more flexible, adaptable, and powerful than any previous version. The Microsoft online support is better, and there are some very good free online tutorials. Provided that you have a high-speed Internet connection, you should be quite pleased with all the extra FrontPage documentation and goodies available from the support site.

I found one quirk in FrontPage 2003 that caught me by surprise. Microsoft classifies FrontPage as a member of the Office product family, so to download FrontPage security patches and program fixes, you have to go to the Web site and use the Office update wizard. The quirk is this: if there are any problems with the way Word or Excel are installed on your PC, it can block you from getting FrontPage patches.

On the PC where I was trying to get FrontPage updates, I had upgraded successively from Office 97 to Office 2000 to Office 2002. The Office update wizard kept prompting me to load the original CDs for the old versions. I found this very annoying, especially since I was not interested in getting updates for the other programs in the Office suite. In my opinion, there should be a way to get FrontPage updates without going through the Office update wizard.

Recommendation:

If you are going to use FrontPage 2003, buy this book: *Microsoft FrontPage 2003 Inside Out* by Jim Buyens, ISBN 0735615101, 1264 pages with a supplemental CD. It has excellent chapters on how FrontPage really works, best development practices, lots of good tips and techniques, and it will help you avoid common problems.



Conclusions:

- ❖ FrontPage provides great leverage for rapid development of an attractive and robust Web site when the complexity of the Web application is low.
- ❖ If you want to develop a complex Web site, you have to spend time learning how FrontPage Web sites operate. You will probably need to get a book or two to help in your mastery of the subject.
- ❖ You may discover that the architecture of FrontPage-developed Web site is not a good fit for the site you want to build. I found this to be true for Web sites that do a lot of interaction with a database, especially when database changes may need to be rolled back and conditional screen logic was used.

Where to buy it:

FrontPage 2003 is widely available. There is a full version and an upgrade version (for people who have an earlier version of FrontPage). The retail prices for these items are \$199 and \$99, respectively, but I saw several Web sites that had both versions for about \$85.

Microsoft FrontPage 2003 Inside Out retails for \$49.95, but you can get it at NerdBooks, <http://www.nerdbooks.com>, for \$27.49.


